# Soft Doggie Cookies

 $3\ (2\ 1/2\ oz.\ each)$  jars of baby food; either beef or chicken

1/4 cup Dry milk powder

1/4 cup Wheat Germ or Cream of Wheat

Combine all ingredients in bowl and mix well. Roll into small balls and place on well-greased cookie sheet. Flatten slightly with a fork. Bake in preheated 350 degree oven for 15 minutes until brown. Cool on wire rack. Refrigerate to keep fresh or freeze.
