Alice Alford provided an update from Lu Dunham, the ACKCSC Local Specialty Clubs Coordinator. The ACKCSC received \$400 from the Betty Turner auction item donated by the club.

Sonya Thompson motioned we purchase 5 items from Betty Turner to hold for future use. Kay-C Phipps Seconded. All Approved.

The 2009 ACKCSC National will be in Hyannis, MA. It will begin on the last weekend in April and continue into May. Ken McDermott will be judging Bitches, while Elaine Lessig will judge Dogs. Patti Caanan will judge Sweepstakes.

Report of Treasurer

Vickie Herring presented the Treasurer's report. Our Total Balance as of June 3, 2008, is \$23,057.03 with monies held in Reserve for the Rescue Fund of \$3,944.14 and the Trophy Fund of \$422.37, resulting in a General Fund balance of \$18,690.52.

Supported Entry:

Vickie Herring provided an update on the All Hallows Eve Cluster. Betty Kraus and Janice Krogg will judge on the Griffin KC days.

Committee Reports

Paula Ayers presented an update about Judges Selection. The committee has identified a possible slate of judges for 2010, and will report when the judges have been contacted and assignments accepted. A list of possible judges for consideration for 2011 is also being complied.

Show Committee:

See update from Alice Alford during the Report of the President.

<u>Program Committee</u>: Alice Alford reported that our July program may be a veterinarian from Georgia Veterinary Specialists (GVS) in Neurology or Ophthalmology. This program may also happen later in the year.

Rescue: Alice Alford and Sonya Thompson explained ACKCS Rescue Trust. Sonya Thompson will be the ACKCS Rescue Chair for the Club. Operating rescue activities under the Trust will provide liability insurance for the club. Membership discussed monies currently in the rescue fund and their uses under the new operational approach. However, the Trust needs volunteers, not funds. Membership further discussed the best way to treat donations specifically earmarked for rescue.

Sonya Thompson provided an overview of the new rescue procedures and available documentation and forms. In the case of rescue's requiring treatment in excess of the approved \$250 Trust allocation per dog, Sonya Thompson will coordinate directly with Renee Bruns of the Trust to gain additional funds approval.

As a result of the change, all who sign up to assist with rescue be volunteers for the National Trust.

Our rescue activities include potential home visits, transportation, temperament assessment, and fostering.

Paula Ayers motioned we move all Rescue funds in to the Health and Education fund. Vickie Herring Seconded. All Approved.

Website/Publicity: Sonya Thompson presented the updated prototype website created using Breederoo. The first year of cost is free of cost to non profit organizations, and then \$19.95 a month with a %10 discount paid in advance. Vickie Herring motioned that we move the club

website to the Breederoo platform. Jeff Herring Seconded. All Approved.

Our History In Rescue

The CKCSCGA Rescue has been in operation for almost 8 years; during this time eleven Cavaliers have come into our care, medical needs provided and placed in forever homes to live out their lives being loved and pampered...as all Cavaliers deserve. Our Rescue efforts began with a ten-month-old tri bitch, Princess Peeper, who had been attacked by a pit-bull and suffered eye injuries. In October 2001, Lu Dunham, president, announced at our monthly meeting we had been contacted by an individual asking us to take Princess Peeper into our care and re-home. At the time we did not have a Rescue Fund in place, so the discussion as to how to fund the medical needs for this girl ensued. Kim Hamer, a member of the club and a veterinarian, offered her services at a greatly reduced cost to the club; the membership decided the proceeds from our upcoming 'B" match would be used for her medical care; and Jeff and Vickie Herring offered to donate \$200 towards her expenses. Thus, Princess Peeper was brought to Atlanta, received the medical care she needed from Kim Hamer and placed in a wonderful forever home. As it was, the proceeds from the "B" match and the donation to the club from the adoptive home covered all of Princes Peepers expenses. Jeff and Vickie Herring asked that their donation not be returned but instead use the money to start a Rescue Fund; Princes Peeper was our first but definitely would not be our last rescue...and so it began. Now 8 years and 11 Cavaliers later the CKCSCGA Rescue is not coming to an end, rather beginning a new chapter of involvement in Rescue where our efforts will be greatly needed. Rescue will never end, unfortunate as it is, it will only grow; there will always be Cavaliers like Princess Peeper, Sailor, Lacy, McKenzie, Charlie, Belle, Harry & the others that will need the Cavalier community to be there for them. Thank you to all of our past Rescue Chairs, Gerri Dueringer, Susan Lewis & Kristin Montalvo.

Our Rescue Takes A New Direction

The changes to Rescue mentioned in last month's "President's Message" have been put into effect. CKCSCGA will work under the umbrella of the "ACKCS Rescue Trust" which will provide us with the liability insurance that the club needs. The guidelines we are to follow and forms we are to use are provided by the Trust. This serves to protect our club & its volunteers from any liability issues, by virtue of proper waivers and insurance coverage.

Though it may seem we still have our own rescue in regards to our "involvement", we no longer will. We will be volunteers for the ACKCS Rescue Trust. I am confident that we will not become complacent, we still have the same responsibility to our breed. We will need your continued support.

This is a summery of how the Trust works & our role in it. Nationally, the country has been divided into Districts, each with it's own Director. Regional Clubs each have a Rescue Chairman who reports to the District Director. CKCSCGA is in District IV and our District Director is Lori Isenhath. All District Directors report to the National Rescue Director Renee Bruns. The Trust has developed a Code of Conduct, all Trust Volunteers are required to acknowledge that they have read, understand and will follow the Code of Conduct. The purpose is to ensure that the best interests of the Cavaliers that come into rescue are served, that liability insurance requirements pertaining to rescue will be met, and that The Trust will be viewed in the most positive light in the eyes of the public and the ACKCSC, Inc.

Our President has asked me to serve as Rescue Chair for our Club. She has assured me I will not have to do this on my own :o). I will interview applicants, handle the paperwork, do home inspections & solicit volunteers. We need people to step forward to be foster homes, we will provide training to ensure that fosters are well-trained and supported in fostering per the guidelines of the Trust.

The detailed information provided by the Trust ensures that volunteers will know exactly what is expected of them, how they are to handle things and what the budget is for each rescue. These funds are covered by the ACKCS Rescue Trust. This information enables our Club, to set our volunteers up for success. So, please do get in touch with me if you are interested in working with Rescue in any way. We will need volunteers for tasks such as home visits, transportation as well as foster homes, so even if you can only donate a little time occasionally, you can still help. One only needs to look into the face of a abused, neglected or frightened cavalier to see that we are needed.


Bojangles & Lizzy



Bojangles and Lizzy are two Cavaliers being turned over to Rescue. Their surrender is not due to neglect or abuse, but is because the family can not afford their care due to some changes in their lives & are doing what they feel is best. We need a Foster home for them until a permanent home can be found. Bojangles is 9, Lizzy is 8. Both are heart clear but overweight. They have been together since puppies and are miserable if separated. They are very friendly with people & kids over five and good with dog friendly cats. They sleep in the bed are not crate trained Bojangles has recurrent ear problems

& dry eye that requires drops each day. Lizzy is afraid of storms. I may have a home for them in the next few weeks. **However, I need a foster home for them NOW**. We want to keep them together if at all possible. If you can't foster but would be willing to help in other ways please let me know. They usually go to the groomer & are in need of a good grooming. Sometimes the best thing for your dogs is not the easiest thing to do. It is not our place to judge but to help. Please if you can foster or would be willing to groom the dogs until a foster can be found let me know. They are in McDonough GA. Thank you. Respectfully,
